Cancellation Policy

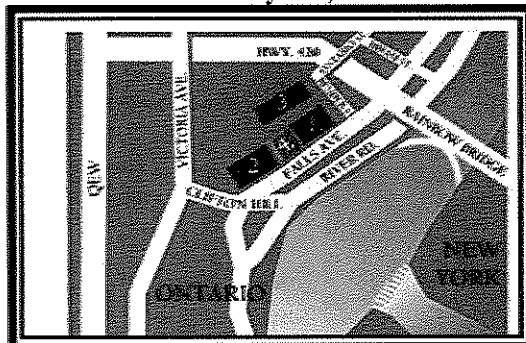
Refunds will not be issued for any cancellations received after March 15th, 2007. A processing fee of \$30.00 will be retained on all cancellations prior to this date.

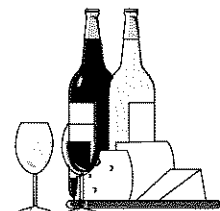

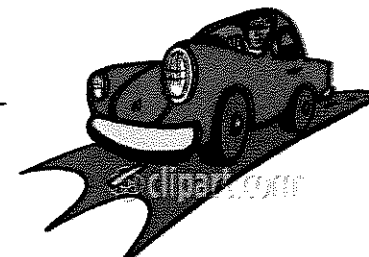
